### Nomination Timeline:

- May 22, 2022 – Call for Nominations Issued
- **June 29, 2022 - Nominations Due**
- July 7, 2022 - Elections Opens
- July 28, 2022 - Elections Concludes
- August 8, 2022 - Election Results Released
- September 8, 2022 – Directors Installed

### Nomination Requirements:

- Individuals eligible for nomination include those within the AIC Professional, Young Professional, Educator, and Fellow Membership classes
- Position carries a 3-year term to begin in September 2022 and end August 2025
- The AIC Board of Directors meets once a year in person at the AIC Annual Conference and Forum
- Directors are to serve on a Committee and attend monthly tele-conferences

### Nomination Instructions:

- Self-nominations are welcome.
- Nominee must sign the Nomination form indicating their willingness to serve if elected.
- Submit the following:
  - o Resume and Short Biography
  - o Separate document answering the following questions (200 Word Maximum):
    - Why do you desire to be an AIC Director?
    - What experiences do you have that would benefit the AIC?
    - Have you served any other construction industry associations?
